ABOUT THE PRODUCT:

NIPPON NEW WEATHERBOND ADVANCE 12 (Quartz) is an all weather protection paint which is formulated with quartz technology and possesses a unique lamination technology with silicone, providing twice the toughness and durability resulting in supreme protection against harsh weather. It has innovative & “Sunblock technology” that reflects 90% of the solar light on exterior walls and reduces surface temperature up to 7 deg C, making the interiors of the house cooler, thus helping to save energy. It provides excellent resistance to flaking, efflorescence and alkali. It has ultra-low VOC ensuring a safe environment. Product comes with 12 years of performance warranty, 5 Years of Anti Algal warranty.

REGISTRATION:

To avail the benefits of warranty it is essential to register warranty with us at by calling 1800 425 3636 or registering it online by visiting www.nipponpaint.co.in

Warranty shall be issued if minimum 60 L of material is purchased.

Warranty period will commence from the date of purchase as evident from invoice of last purchase of the product. Hence it is mandatory that warranty to be registered within 15 days from purchase of the product.

Unique Identity Number (UIN) which is available on the barcode sticker pasted over the container will make the warranty registration process easy and hence customers are requested to retain the paint containers or the Bar code stickers till the warranty gets registered successfully. Please note warranty can be registered without UIN numbers also.

This Warranty and Warranty T&C's shall apply only if the total volume of New Weather Bond Advance purchased at a single site is between 60 L to 200 L.

For sites where total purchase of NIPPON NEW WEATHERBOND ADVANCE 12 (Quartz) exceeds 200 L, special terms and conditions is applicable, please get in touch with our representatives for the same and the warranty is subject to a satisfactory Pre- inspection of the surface to be painted by the company representative. After completion of painting again an inspection will done by company representative and warranty shall be issued if inspection found to be satisfactory.

WARRANTY COVER:

Throughout this warranty, paint failure shall mean any one of the following occurring, subject to terms and conditions laid down in this warranty

- (a) Film integrity, flaking, peeling off New Weatherbond Advance 12 (Quartz) by one coat of paint coming off from another or the paint comes off from wall.
- (b) Cracks developed in film due to non-formation of paint film.
- (c) Shade Fading
- (d) Algal / Fungal growth on vertical wall surfaces only (minimum spread over area atleast one sq m / 10 sq ft. Anti Algal / Fungal warranty is only for period of 5 years from the commencement date.

CONDITIONS AND LIMITATIONS:

The warranty shall apply

- (a) When New Weatherbond Advance 12 (Quartz) product has been applied on recommended surface.
- (b) The entire painting system is as recommended by the company.
- (c) Proper surface preparation carried as per company's recommendation (Please refer Technical data sheet for recommended system, surface).
- (d) White cement is not applied as undercoat.
- (e) Dr. Bond Efflorescence Resistant Primer applied as undercoat.
- (f) Weatherbond Advance 12 (Quartz) coverage is 5.10 – 6.03 Sq m /L/2 Coats.

EXCLUSIONS:

This warranty shall not cover defects caused directly or indirectly by any one or more of the following factors and the company's decision on the cause of the defect shall be final and binding.

- (a) Due to improper storage or handling of the Product.
- (b) Due to substandard and / or defective workmanship in the execution of work.

EXCLUSIONS:

- (c) Deterioration of paint film including but not limited to staining, efflorescence, Algal/fungal growth caused from constant dampness around and within the walls from air conditioning units, high moisture retention caused from water seepage, source of water leakage like plant pots, intermittent dripping of water due to proximity of vegetation, capillary rise of ground level water or defects of similar nature.
- (d) Defects caused from insufficient paint film thickness that does not cover substrate adequately.
- (e) Poor or improper surface preparation and paint application procedure or surface with contaminant and not dry. If white cement/lime applied as undercoat.
- (f) Trace difference in color or texture of new materials being supplied for repair work against previous material.
- (g) Claims of indirect, incidental or consequential damages resulting from breach of this warranty are specifically excluded.
- (h) Failure to follow the instructions of the Company on preparation of surface before application of the Product and failure to undertake maintenance of the surface as prescribed by the Company
- (i) Factors out of the Company's control
- (j) Paint Failures due to structural defects, excessive bird dropping, spitting, and staining due to plant pots
- (k) Natural calamities such as earthquakes, cyclones, abnormal rain or flood etc.;
- (l) Failure or defects in structure or in previous coat
- (m) Vandalism or heavy impact on the paint film with objects like furniture or sharp edges
- (n) Abuse or negligence by customer.
- (o) Normal wear and tear.
- (p) Growth of Algae / Fungi less than one Sq m / 10 Sq ft area and on horizontal areas.
- (q) Surface deposition of Algae /fungus, dirt or contaminant that can be removed through periodic cleaning. Fungus that can be washed off is classified as a foreign layer deposited on paint film.

CLAIM PROCEDURE:

- (a) Any claims under this warranty should be intimated to the company (in the manner prescribed below) not later than one week from the day when the defect giving rise to the claim is first discovered.
- (b) Intimation of claims should be made by any of the following means:
 - a. calling toll free number: 1800 425 3636;
 - b. sending an email to: tu@nipponpaint.co.in
- (c) On receipt of intimation of a claim, the company will arrange for its representative to visit your site and evaluate the nature of the complaint. Should the findings of the inspection conclude that the claim falls within the scope of this warranty, the company shall provide the limited benefits as detailed in the section below.
- (d) The original invoice issued at the time of purchase of the product and the original warranty card must be produced to avail of the benefits under this warranty.

COMPANY'S LIMITED LIABILITY:

The company's liability is limited to material or material and labor cost for the affected area only and any other related, incidental or consequential cost shall be borne by the customer.

Subject to the terms of this warranty, in the event of paint failure due to manufacturing defects that occur during the relevant warranty period, the company will provide the following:

- (a) The company will offer, either the required quantity of equivalent or comparable product at no charge, or the price of the required quantity of the product (at the market rate prevailing on the date when the claim is lodged) as is necessary to repair the affected area only. The company will determine the extent of the affected area and the quantity of product that will be sufficient to repair specific areas affected by the defect. The company's decision on all of the above matters (which shall be made in its sole discretion) shall be final and binding.
- (b) The Company will pay the labour costs required to repair specific area affected by the defect. The Company will estimate the labour cost required to repair the affected area based on the existing market rate in the location of the site. The labour cost may be determined on basis of a per sq. ft. rate or on a daily wages basis. The Company's determination of appropriate labour costs and the basis for the costing shall be final and binding.

COMPANY'S LIMITED LIABILITY:

(c) Benefits under this Warranty will be made available only if (i) Warranty is registered (ii) the said benefits are accepted as full and final settlement of all claims against the Company and (ii) agrees to keep the facts and all matters concerning the defects, claim and the benefits provided under this Warranty confidential at all time.

Where any claim arises during the warranty period, the period will not start afresh after settlement of the claim.

JURISDICTION:

All disputes arising from, related to or in connection with this warranty will be subject to the exclusive jurisdiction of appropriate courts in Chennai, to the exclusion of any other court that may have jurisdiction in such matters.

MISCELLANEOUS:

Except as expressly warranted herein, the company expressly disclaims all warranties of any kind, whether express or implied or statutory, including, but not limited to the implied warranties of merchantability, quality or fitness for particular purpose.

The Company shall use its reasonable efforts to ensure that the replacement material required for the repairs is available to customer as soon as possible, but does not assume any liability for any delay caused in this respect.

The company reserves the right to visit the site to carry out inspection at the site where claim has been raised. Customer should not do any rectification or repairs of the affected areas before such visits, if done so then the warranty becomes null and void.

All disputes arising from, related to or in connection with this Warranty will be subject to the exclusive jurisdiction of appropriate courts in Chennai, to the exclusion of any other Court that may have jurisdiction in such matter.
